

## **TOYOTA TRADE PARTS CLUB OFFICIAL SIGNED ENGLAND CRICKET SHIRT PRIZE DRAW TERMS AND CONDITIONS**

### **1. The Promoter**

The Promoter is: Toyota (GB) Plc (registered under company number 00916634 at Great Burgh, Burgh Heath, Epsom, Surrey KT18 5UX) (the "Promoter").

The Administrator is: OEConnection Limited (registered under company number 02354459 at Construction House, Winchester Road, Burghclere, Newbury, RG20 9EQ).

### **2. The Promotion**

2.1 The Promoter will be running a prize draw where participants will have the opportunity to win one (1) framed and signed official England Cricket Shirt (the "Prize"). The Prize will either be a signed official men's England Cricket Shirt or a signed official women's England Cricket Shirt, depending on availability.

2.2 The Administrator shall be responsible for managing the Promotion.

2.3 The Administrator will select one (1) winner.

2.4 The Prize is not eligible for exchange.

### **3. How to enter**

3.1 The Promotion will run from 1200 hours on Friday 1st August 2025 (the "Opening Date") to 1200 hours on Tuesday 30th September 2025 (the "Closing Date") inclusive.

3.2 To be eligible the participant must be:

- (a) an Independent Garage or Bodyshop;
- (b) UK company including Northern Ireland; and
- (c) be a member of the Toyota Trade Parts Club.

3.3 An Independent Garage means a business that operates independently of any OEM and/or vehicle retail outlet or group, whose main business derives solely from vehicle repair and maintenance services included but not limited to MOT testing, vehicle servicing, maintenance and repairs.

3.4 A Bodyshop means a business whose activities derive solely or substantially from vehicle accident repair whether or not that business is independent or associated with an OEM, vehicle retailer or repairer and/or insurer.

3.5 All Promotion entries must be received by the Promoter via the completion of the online entry form provided on [www.toyotatradeparts.co.uk](http://www.toyotatradeparts.co.uk) by no later than 1200 hours on the Closing Date. All Promotion entries received after the Closing Date are automatically disqualified. Entries must include a valid email address where requested by the Promoter.

- 3.6 It is the responsibility of the Participants to ensure that all information provided is accurate and complete.
- 3.7 The winner will be the entry selected at random from all correct eligible entries.
- 3.8 No purchase necessary. There is no charge to participate via the website.
- 3.9 The Promoter will not accept:
- (a) responsibility for Promotion entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - (b) proof of transmission as proof of receipt of entry to the Promotion.
- 3.10 By participating in this Promotion, you are agreeing to be bound by these terms and conditions.

#### **4. Eligibility**

- 4.1 Subject to any other provisions of these terms and conditions, this Promotion is open to all UK (including Northern Ireland) Independent Garages and Bodyshops who are a member of the Toyota Trade Parts Club.
- 4.2 For the avoidance of doubt, if an eligible Independent Garage or a Bodyshop want to enter the Promotion and they are not members of the Toyota Trade Club, they will need to sign up prior to entering the Promotion for their entry to become eligible. Independent Garages and Bodyshop can sign up to become members at <https://www.toyotatradeparts.co.uk/home>.
- 4.3 Registration and acceptance is subject to review by Toyota in accordance with these terms and conditions. Such decision shall be final, and no correspondence shall be entered into.
- 4.4 In entering this Promotion, you confirm that your business is eligible to do so and eligible to claim the Prize you may win. The Administrator may require you to provide proof that you are eligible to enter this Promotion.
- 4.5 Winning entries will be checked for eligibility by the Promoter and Administrator comparing the entry details against the registered details held on the Toyota Trade Club membership details. If a winning entry is found to be ineligible, a new winner will be selected at random from all remaining entries until an eligible winning entry is selected.
- 4.6 The Promoter and Administrator will not accept entries that are:
- (a) automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);
  - (b) completed by third parties or in bulk;
  - (c) illegible, have been altered, reconstructed, forged or tampered with;
  - (d) photocopies and not originals;
  - (e) incomplete;
  - (f) false, misleading, fraudulent, derogatory, offensive or otherwise contrary to the spirit in which the Promotion is conducted.

- 4.7 There is a limit of one entry to this Promotion per Independent Garage or Bodyshop. Entries on behalf of another Independent Garage or Bodyshop will not be accepted, and joint or multiple submissions are not allowed. Entries submitted via any automated or similar systems will not be accepted.
- 4.8 The Promoter and Administrator reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of this Promotion.

## **5. The prize**

- 5.1 The Prize is one (1) framed and signed official England Cricket Shirt manufactured by Castore.
- 5.2 The Prize will either be a signed official Men's England Cricket shirt or a signed official Women's England Cricket shirt, depending on availability.
- 5.3 The winner will not have the option to select between a signed official Men's England Cricket shirt or a signed official Women's England Cricket shirt as the Prize. The Prize is subject to availability.
- 5.4 The signed official Men's England Cricket shirt will be signed by members of the England Men's Test Team, England Men's ODI Team and England Men's T20 Team.
- 5.5 The signed official Women's England Cricket shirt will be signed by members of the England Women's Test Team, England Women's ODI Team and England Women's T20 Team.
- 5.6 The Prize is supplied by the England and Wales Cricket Board Limited (the "Prize Provider"). There is no cash alternative. The Prize Provider and Promoter reserves the right to substitute the prize with an alternative prize of equal or higher value if it is necessary to do so.
- 5.7 The Promoter or Administrator shall not be responsible for the condition, completeness, or content of the Prizes, including but not limited to the presence or absence of any expected signatures. The Promoter and Administrator has no control over the provision or quality of the Prizes and disclaims any liability for any defects, omissions, or issues arising in connection therewith.
- 5.8 The prize is not negotiable, transferable or exchangeable.

## **6. Winners**

- 6.1 The Administrator will draw one (1) winner of the Prize at random from all eligible entries received by the Closing Date.
- 6.2 The decision of the Administrator is final, and no correspondence or discussion will be entered into.

- 6.3 The Administrator will contact the winner as soon as practicable after 09:00 7th October 2025 using the email address provided with the promotion entry to notify them that they are a winner of the Prize. It is the responsibility of the participant to ensure they check their "junk" folder for this notification.
- 6.4 If the Administrator is unable to contact the winner within 14 days, a new winner will be selected at random from all remaining eligible entries. This process will be repeated until all prizes are fulfilled.

## **7. Claiming the prize**

- 7.1 If you are the winner of the Prize, you will have four (4) days to claim the Prize. Instructions on how to claim the Prize will be set out in the notification e-mail received after the winner is drawn. If you do not claim the Prize by this date, your claim will become invalid.
- 7.2 Once the winner has claimed the Prize, the Winner can provide instructions on the address to send the Prize. The address must be a business address.
- 7.3 The Prize will be delivered by post, please allow 30 days for this to arrive.
- 7.4 The Administrator will make all reasonable efforts to contact the winner. If the winner cannot be contacted, or is not available, or has not claimed their prize within 4 (four) days of the date they are contacted, the Administrator reserves the right to offer the prize to the next eligible participant selected from the entries that were received before the Closing Date. For the avoidance of doubt, in circumstances where a replacement winner is selected in accordance with this condition 7.4, the Administrator shall advise within the notification e-mail the number of days for the replacement winner to claim the Prize.
- 7.5 The Promoter and Administrator does not accept any responsibility if you are not able to take up the Prize.

## **8. Limitation of liability**

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors.

## **9. General**

- 9.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter and Administrator, at its sole discretion, reserves the right to exclude you from participating in this promotion.
- 9.2 The Promoter reserves the right to void, suspend, cancel, or amend the terms of this promotion at any stage and without notice if deemed necessary in their opinion, and/or if circumstances arise outside of their control, with no liability to any participant or third party.
- 9.3 No third party can enforce these terms.

- 9.4 These terms and conditions constitute the entire agreement between the parties with respect to the subject matter.
- 9.5 In the event of a conflict between these terms and any other terms or instructions related to this Promotion, these terms and conditions take precedence.
- 9.6 These terms and conditions are governed by English law and are subject to the exclusive jurisdiction of the English Courts.
